

Get help to juggle work and life...

There is a range of government support to help with childcare costs, whether you have toddlers or teens you could get support.

Tax-Free Childcare

If you get Tax-Free Childcare, you'll set up an online childcare account for your child. For every £8 you pay into this account, the government will pay in £2 to use to pay your provider. You can use it to pay for childminders, nurseries, after school clubs and play schemes.

You can get Tax-Free Childcare at the same time as 15 or 30 hours funded childcare if you're eligible for both.

Your child must be 11 or under and usually lives with you.

Early Years Entitlements for children aged 9 months to 4 years – for working parents

You may be able to get free childcare for your child aged 9 months to 4 years old if you live in England.

The amount of free childcare you can get depends on:

- · your child's age and circumstances
- whether you're working (employed, self-employed, or a director)
- your income (and your partner's income, if you have one)
- your immigration status

Government support for childcare costs for working parents

Early Years Entitlement for 2-year-olds – for families that claim certain benefits

If you have a 2-year-old and you claim certain benefits, you may be eligible for 15 hours of funded childcare under a separate scheme.

Early Years Entitlement for 3 & 4-year-olds – universal entitlement for ALL children

All children that live in the UK are entitled to 15 hours of funded childcare from the term following their 3rd birthday.

Universal Credit

You may be able to claim back up to 85% of your childcare costs if you're eligible for Universal Credit. You (and your partner if you live with them) will usually need to either:

- be working it does not matter how many hours you or your partner work
- have a job offer

Wraparound Childcare

Wraparound childcare is before and after school childcare for primary school aged children in England.

The provision typically runs from around 8am until 6pm, during term time, either on a school site or another local setting such as a community centre, a nursery, or a childminder.

This is different from out-of-school activities, or school clubs, which are less frequent and can be a one-off activity.

All parents in England with primary school aged children are eligible to access wraparound childcare.
